**Notification on RSPO Certification Annual Surveillance of MINAMAS Plantation – SIME DARBY GROUP (PT. Kridatama Lancar – Sukamandang POM)**

Dear Stakeholders,

MINAMAS Plantation has applied to Mutuagung Lestari for Annual Surveillance at PT Kridatama Lancar – Sukamandang Palm Oil Mill and its supply based, located in District of Kotawaringin Timur, Province of Central Kalimantan against the requirement of the SPO Standard i.e. National Interpretation of Roundtable Sustainable Palm Oil, Principles and Criteria (RSPO INA – NIWG, May 2008) Republic of Indonesia and Supply Chain Requirement for CPO Mill.

MINAMAS Plantation owned and operated 23 palm oil mills and 68 estates throughout Indonesia. The organization is a pioneer member of RSPO and has been taking an active role in the RSPO certification processes. MINAMAS Plantation is implementing programme to achieve RSPO Certified Sustainable Palm Oil for all of its production by 31 December 2011. Currently there were 8 mills under Minamas Plantation have been certified.

Since July 05, 2011 PT Kridatama Lancar has been certified (No. MUTU – RSPO/003) and this certification will expired on July 05, 2016. Mutuagung Lestari has arranged to conduct the annual surveillance assessment of PT Kridatama Lancar which has 1 (one) mill and 4 (four) estates on **December 19-24, 2011**.

Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body (ISO 14001;2004). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since June 2008, MUTU has been approved by RSPO Executive Board as a RSPO certification body.

1. **Deni A Novendi** as Lead Auditor (Legal, Environment Management System, Conservation);
2. **Muardi Marwas** as auditor (Good Agriculture Practices, Integrated Pest Management);
3. **Ibnu Satria Prabudi** as Auditor (Social aspect, Health and Safety, Workers Welfare )

as minimum 1 (one) lead auditor and 2 (two) auditor members which have competencies in legal, social environment, and best management practices.

PT. Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment,

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
