Smart Tbk. has applied to Mutuagung Lestari for RSPO annual surveillance to Semilar POM – PT Tapian Nadenggan (RSPO Membership: 1-0019-05-000-00) and its supply based, located in Subdistrict of Danau Seluluk, District of Seruyan, Province of Kalimantan Tengah against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Smart Tbk. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Smart Tbk. has been registered since January 30, 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the certification assessment of PT Tapian Nadenggan which has 1 (one) palm oil mill and 4 (four) oil palm estates on 15th to 20th May 2017

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China.
