Notification on RSPO Surveillance-1 Assessment of Pundu Nabatindo POM – PT Windu Nabatindo Lestari (Bumitama Agri Ltd)

Burnitama Agri Ltd has applied to Mutuagung Lestari for RSPO annual surveillance to Gunung Makmur POM – PT Karya Makmur Bahagia (RSPO Membership Number 1-0043-07-000-00) and its supply based, located in Village of Pundu, Sub District of Cempaga Hulu, District Of Kotawaringi Timur, Province of Central Kalimantan, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

Burnitama Agri Ltd has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Burnitama Agri Ltd has been registered since October 8, 2007 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Pundu Nabatindo POM – PT Windu Nabatindo Lestari which has 1 (one) mill and 4 (four) estates on 20 – 25 April 2015.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body (ISO 14001;2004). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
