Sime Darby Plantation Sdn. Bhd has applied to Mutuagung Lestari for RSPO annual surveillance to Rantau POM – PT Laguna Mandiri (RSPO Membership Number 1-0008-04-000-00) and its supply based, located in Sub District of Pamukan Utara, District of Kotabaru, Kalimantan Selatan Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

Sime Darby Plantation Sdn. Bhd has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Sime Darby Plantation Sdn. Bhd has been registered since September 07, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Rantau POM – PT Laguna Mandiri which has 1 (one) mill and 3 (three) estates on **05 – 13 Oktober 2015.**

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China.
