PT PP London Sumatra Indonesia Tbk has been registered since Noember 05, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Turangie POM – PT PP London Sumatra Indonesia Tbk which has 1 (one) mill and 3 (three) estates on **19 – 23 October 2015.**

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally.
