<u>Notification on RSPO Surveillance-4 Assessment of Alur Dumai POM – PT Lahan Tani Sakti (Sime Darby</u> <u>Plantation Sdn. Bhd)</u>

Dear Stakeholders,

Sime Darby Plantation Sdn. Bhd has applied to Mutuagung Lestari for RSPO annual surveillance to Alur Dumai POM – PT Lahan Tani Sakti (RSPO Membership Number 1-0008-04-000-00) and its supply based, located in Sub District of Pujud, District of Rokan Hilir, Riau Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

Sime Darby Plantation Sdn. Bhd has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Sime Darby Plantation Sdn. Bhd has been registered since September 07, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Alur Dumai POM – PT Lahan Tani Sakti which has 1 (one) mill and 1 (one) estates on **26**th – **30**th **October 2015.**

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam,Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

- 2. Moh Arif Yusni as Auditor for Social Aspect, Safety and Health, and Enviromental Management.
- 3. Andi Pratama Pasaribu as Auditor for Quality Management Worker Welfare System, and Bese Agricultural Practices.
- 4. Fuji Lestari as Auditor for Social Aspect and Quality Management Worker Welfare System.

PT. Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment,

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
