Wilmar International Ltd. has applied to Mutuagung Lestari for RSPO annual surveillance to STP POM – PT Sarana Titian Permata (RSPO Membership Number 2-0017-05-000-00) and its supply based, located in Sub District of Kateman, District of Indragiri Hilir, Riau Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

Wilmar International Ltd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Wilmar International Ltd. has been registered since August 16, 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance-3 of STP POM – PT Sarana Titian Permata which has 1 (one) mill and 3 (three) estates on **08 – 12 November 2015**.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990.
