## Notification on RSPO Surveillance-2 Assessment of POM 3 – PT Dharma Satya Nusantara (PT Dharma Satya Nusantara)

Dear Stakeholders,

PT Dharma Satya Nusantara has applied to Mutuagung Lestari for RSPO annual surveillance to POM 3 – PT Dharma Satya Nusantara (RSPO Membership Number 1-0135-12-000-00) and its supply based, located in Village of Muara Wahau, Sub District of Muara Wahau, District of Kutai Timur, Province of East Kalimantan, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

PT Dharma Satya Nusantara has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Dharma Satya Nusantara has been registered since 4 December 2012 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of POM 3 – PT Dharma Satya Nusantara which has 1 (one) mill and 7 (seven) estates on **15 – 20** Januari 2016.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body (ISO 14001;2004). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

- 2. Sandra Purba as Auditor for Safety and Health, and Worker Welfare.
- 3. Rudi Ramdani as Auditor for High Conservation Value, Social Aspect, and Waste Processing.
- 4. Randytio Puspanjana as Auditor for Social Aspect, and Base Management Practices.

PT Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment,

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
