Notification on RSPO Surveillance-2 Assessment of Gersindo Minang Plantation POM – PT Gersindo Minang Plantation (Wilmar International Ltd.)

Dear Stakeholders,

Wilmar International Ltd. has applied to Mutuagung Lestari for RSPO annual surveillance to Gersindo Minang Plantation POM – PT Gersindo Minang Plantation (RSPO Membership Number 2-0017-05-000-00) and its supply based, located in Jorong Tanjung Pangkal, Sub District of Pasaman, District of Pasaman Barat, Sumatera Barat Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

Wilmar International Ltd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Wilmar International Ltd.has been registered since August 16, 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Gersindo Minang Plantation POM – PT Gersindo Minang Plantation which has 1 (one) mill and 3 (three) estates on 18 – 24 January 2016.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body (ISO 14001;2004). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.
