# Notification on RSPO Surveillance-1 Assessment of Sungai Bengkal POM – PT Satya Kisma Usaha (SMART Tbk)

Dear Stakeholders,

SMART Tbk has applied to Mutuagung Lestari for RSPO annual surveillance to Sungai Bengkal POM – PT Satya Kisma Usaha (RSPO Membership Number 1-0019-05-000-00) and its supply based, located in Betung Bedarah Barat Village, Sub District of Tebo Ilir, District of Tebo, Jambi Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

SMART Tbk has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. SMART Tbk has been registered since January 30, 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Sungai Bengkal POM – PT Satya Kisma Usaha which has 1 (one) mill and 3 (three) estates on **11 – 15 January 2016.** 

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body.
