**Notification on RSPO Surveillance-2 Assessment of Sulung POM – PT Sawit Sumbermas Sarana**

Dear Stakeholders,

PT Sawit Sumbermas Sarana has applied to Mutuagung Lestari for RSPO annual surveillance to Sulung POM – PT Sawit Sumbermas Sarana (RSPO membership number 1-0111-07-000-00) and its supply based, located in Village of Sulung, Sub District Arut Selatan, District of Kotawaringin Barat, Central Kalimantan, Indonesia against the requirement of the SPO Standard i.e. National Interpretation of Roundtable Sustainable Palm Oil, Principles and Criteria (RSPO INA – NIWG, May 2008) Republic of Indonesia and Supply Chain Requirement for CPO Mill.

PT Sawit Sumbermas Sarana has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. PT Sawit Sumbermas Sarana has been registered since 18 April 2007 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Sulung POM – PT Sawit Sumbermas Sarana which has 1 (one) mill and 7 (seven) estates on **23-27 February 2015**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body (ISO 14001;2004). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

PT Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment,

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
