<u>Notification on RSPO Surveillance-4 Assessment of Pondok Labu POM – PT Paripurna Swakarsa – Sime</u> <u>Darby Plantation</u>

Dear Stakeholders,

Sime Darby Plantation Sdn. Bhd. has applied to Mutuagung Lestari for RSPO annual surveillance to Pondok Labu POM – PT Paripurna Swakarsa (RSPO Membership Number 1-0008-04-000-00) and its supply based, located in Pamukan Selatan Sub District, Kotabaru District, Kalimantan Selatan Province, Indonesia against the requirement of the Roundtable on Sustainable Oil Palm, Principles and Criteria of Roundtable on Sustainable Palm Oil, Generic Standard April 2013 and Supply Chain Requirement for CPO Mill, November 2014.

Sime Darby Plantation Sdn. Bhd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Sime Darby Plantation Sdn. Bhd. has been registered since September 7, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Pondok Labu POM – PT Paripurna Swakarsa which has 1 (one) mill and 4 (four) estates on **20 - 24 February 2016**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

- 4. **Doni** as auditor for Social Aspect, Quality management System.
