<u>Notification on RSPO Surveillance-4 Assessment of Selabak POM – PT Swadaya Andika – Sime Darby</u> <u>Plantation</u>

Dear Stakeholders,

Sime Darby Plantation Sdn. Bhd. has applied to Mutuagung Lestari for RSPO annual surveillance to Selabak POM – PT Swadaya Andika (RSPO Membership Number 1-0008-04-000-00) and its supply based, located in Selabak Village, Sungai Durian Sub District, Kotabaru District, Kalimantan Selatan Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

Sime Darby Plantation Sdn. Bhd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Sime Darby Plantation Sdn. Bhd. has been registered since September 7, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Selabak POM – PT Swadaya Andika which has 1 (one) mill and 4 (four) estates on **25 – 28** January, **2016**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

The assessor team for the certification assessment will consist of:

- 1. Moh. Arif Yusni as Lead Auditor for Legal Aspect, and Supply Chain.
- 2. Leonada as Auditor for Base Management Practice, and Occupation Health and Safety
- 3. Panggading as Auditor for Social Aspect and Worker Welfare.
- 4. Steve Mualim as Auditor for High Conservation Value and GHG.

PT Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment,

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
