# Notification on RSPO Surveillance-1 Assessment of Tanjung Kembiri POM – PT Foresta Lestari Dwikarya – Golden Agri Resources Ltd.

Golden Agri Resources Ltd. has applied to Mutuagung Lestari for RSPO annual surveillance to Tanjung Kembiri POM – PT Foresta Lestari Dwikarya (RSPO membership number 1-0096-11-000-00) and its supply based, located in Kembiri Village, Membalong Sub District, Belitung District, Bangka Belitung Province, Indonesia against the requirement of the SPO Standard i.e. National Interpretation of Roundtable Sustainable Palm Oil, Principles and Criteria (RSPO INA – NIWG, May 2008) Republic of Indonesia and Supply Chain Requirment for CPO Mill.

Golden Agri Resources Ltd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Golden Agri Resources Ltd. has been registered since 31 March 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Tanjung Kembiri POM – PT Foresta Lestari Dwikarya which has 1 (one) mill and 2 (two) estate on **3-6 March 2015.**
