Wilmar International Ltd. has applied to Mutuagung Lestari for RSPO annual surveillance to Agronusa Investama POM – PT Agronusa Investama (RSPO Membership Number 2-0017-05-000-00) and its supply based, located in Semanga Village, Sejangkung Sub-district, Sambas District, Kalimantan Barat Province, Indonesia against the requirement of the Roundtable on Sustainable Oil Palm, Principles and Criteria of Roundtable on Sustainable Palm Oil, Generic Standard April 2013 and Supply Chain Requirement for CPO Mill, November 2014.

Wilmar International Ltd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Wilmar International Ltd. has been registered since 16 August 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Agronusa Investama POM – PT Agronusa Investama which has 1 (one) mill and 1 (one) estate on 15 – 20 February 2016

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally.
