**Notification on RSPO Surveillance-2 Assessment of Muara Wahau POM – PT Kresna Duta Agroindo (PT SMART Tbk).**

Dear Stakeholders,

PT SMART Tbk has applied to Mutuagung Lestari for RSPO annual surveillance to Muara Wahau POM – PT Kresna Duta Agroindo (RSPO Membership Number 1-0019-05-000-00) and its supply based, located in Sukamaju Village, Sub District of Kongbeng, District of Kutai Timur, Province of East Kalimantan, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

PT SMART Tbk has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. PT SMART Tbk has been registered since January 30, 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Muara Wahau POM – PT Kresna Duta Agroindo which has 1 (one) mill and 2 (two) estates on **15<sup>th</sup> – 19<sup>th</sup> May 2016**.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body (ISO 14001; 2004). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

1. **Sandra Purba** as Lead Auditor for Occupation Health and Safety and Worker Welfare and Supply Chain;
2. **Yudwi Wisnu Rahmanto** as Auditor for Legal Aspect, HCV and Social Aspect;
3. **Moh Arif Yusni** as Auditor for Transparency, Best Management Practice on Agronomy and Mill Processing;
4. **Sofyan Hadi Lubis** as Auditor for Environmental, GRK and Waste Management;

PT. Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment;

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
