PT Bhumireksa Nusasejati subsidiary of Sime Darby Plantation Sdn Bhd (RSPO Membership: 1-0008-04-000-00, 7 September 2004) has applied to Mutuagung Lestari and will conduct Re-Certification at Teluk Bakau POM and its supply base, located in Village of Rotan Semelur, Sub-district of Kateman, District of Indragiri Hilir, Riau Province, Indonesia against the requirement of the Roundtable on Sustainable Oil Palm, Principles and Criteria of Roundtable on Sustainable Palm Oil, Generic Standard April 2013 and Supply Chain Requirement for CPO Mill, November 2014.

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) oil mill and 3 (three) palm oil estates on **26 to 30 September 2016**.
