Notification on RSPO Re-Certification of Ramarama POM, PT Ramajaya Pramukti subsidiary of Ivo Mas Tunggal (RSPO Membership: 1-0056-08-000-00, 17 June 2008)

Dear Stakeholders,

PT Ramajaya Pramukti subsidiary of Ivo Mas Tunggal (RSPO Membership: 1-0056-08-000-00, 17 June 2008) has applied to Mutuagung Lestari and will conduct Re-Certification at Ramarama POM and its supply base, located in Village of Petapahan, Sub-district of Tapung, District of Kampar, Riau Province, Indonesia against the requirement of the Roundtable on Sustainable Oil Palm, Principles and Criteria of Roundtable on Sustainable Palm Oil, Generic Standard April 2013 and Supply Chain Requirement for CPO Mill, November 2014.

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) oil mill and 3 (three) oil palm estates on **27 to 30 September 2016.**
