# Notification on RSPO Surveillance-4 Assessment of Mandau POM – PT Adei Plantation and Industry (Kuala Lumpur Kepong Bhd)

Dear Stakeholders,

Kuala Lumpur Kepong Bhd has applied to Mutuagung Lestari for RSPO annual surveillance to Mandau POM – PT Adei Plantation and Industry (RSPO Membership Number 1-0014-04-000-00) and its supply based, located in Village of Muara Basung, Sub District of Pinggir, District of Bengkalis, Province of Riau, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

Kuala Lumpur Kepong Bhd has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Kuala Lumpur Kepong Bhd has been registered since October 18, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Mandau POM – PT Adei Plantation and Industry which has 1 (one) mill and 7 (seven) estates on 8 – 13 August 2016.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia.
