PT Ivo Mas Tunggal has applied to Mutuagung Lestari for RSPO annual surveillance to Ujung Tanjung POM – PT Ivo Mas Tunggal (RSPO Membership Number 1-0056-08-000-00) and its supply based, located in Sub District of Kandis, District of Siak, Riau Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

PT Ivo Mas Tunggal has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. PT Ivo Mas Tunggal has been registered since June 17, 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Ujung Tanjung POM – PT Ivo Mas Tunggal which has 1 (one) mill and 1 (one) estate on **25th July until 05th August 2016.**

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB).
