# <u>Notification on RSPO Surveillance-4 Assessment of Mill 1 POM – PT Swakarsa Sinar Sentosa a subsidiary</u> of PT Dharma Satya Nusantara (RSPO Membership: 1-0064-08-000-00, 28<sup>th</sup> July, 2008)

Dear Stakeholders,

Dharma Satya Nusantara Group has applied to Mutuagung Lestari for RSPO annual surveillance to Mill 1 POM – PT Swakrsa Sinarsentosa (RSPO Membership Number 1-0064-08-000-00) and its supply based, located in Sub District of Muara Wahau, District of Kutai Timur, Kalimantan Timur Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

Dharma Satya Nusantara Group has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Dharma Satya Nusantara Group has been registered since July 28, 2008 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Mill 1 POM – PT Swakarsa Sinar Sentosa which has 1 (one) mill, 1 (one) estate and 2 (two) smallholders on **21th –25th November 2016**.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2008) and Environmental Management System certification body (ISO 14001;2004). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body.
