SMART Tbk has applied to Mutuagung Lestari for RSPO annual surveillance to Sungai Bengkal POM – PT Satya Kisma Usaha (RSPO Membership Number 1-0019-05-000-00) and its supply based, located in Betung Bedarah Barat Village, Sub District of Tebo Ilir, District of Tebo, Jambi Province, Indonesia against the requirement of the Generic RSPO Principles and Criteria (P&C) for Sustainable Palm Oil Production, April 2013 and RSPO Supply Chain Certification Standard November 2014 for CPO Mill.

SMART Tbk has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. SMART Tbk has been registered since January 30, 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Sungai Bengkal POM – PT Satya Kisma Usaha which has 1 (one) mill and 3 (three) estates on **09th – 14th January 2017.**
