Notification on RSPO Surveillance-3 Assessment of Tanjung Kembiri POM – PT Forestalestari Dwikarya a subsidiary of Golden Agri Resources Ltd.

Dear Stakeholders,

Golden Agri Resources Ltd has applied to Mutuagung Lestari for RSPO annual surveillance to Tanjung Kembiri POM – PT Forestalestari Dwikarya (RSPO membership number 1-0096-11-000-00) and its supply based, located in Kembiri Village, Membalong Sub District, Belitung District, Bangka Belitung Province, Indonesia against the requirement of the RSPO Principles and Criteria Indonesian National Interpretation 2013, endorsed September 2016 and Supply Chain Requirement for CPO Mill, November 2014.

Mutuagung Lestari has arranged to conduct the annual surveillance of Tanjung Kembiri POM – PT Forestalestari Dwikaryawhich has 1 (one) mill and 2 (two) estate on **06 – 09 February 2017**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001;2015) and Environmental Management System certification body (ISO 14001;2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

The assessor team for the certification assessment will consist of:

1. **Trismadi Nurbayuto** as lead auditor for legal aspect, land tenure, conflict management and supply chain.
2. **Andi Pratama Pasaribu** as auditor for OHS, Good Agricultural Practices and Good Manufacturing Practices.
3. **Yohanes Hardian** as auditor for Conservation and Environmental Aspect.
4. **Rizliani Aprianita** as auditor for social aspect, worker welfare, and transparency information.

PT Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment,

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
