Notification on RSPO Surveillance-4 Assessment of Agronusa Investama POM – PT Agronusa Investama a subsidiary of Wilmar International Ltd.

Dear Stakeholders,

Wilmar International Ltd. has applied to Mutuagung Lestari for RSPO annual surveillance to Agronusa Investama POM – PT Agronusa Investama (RSPO Membership Number 2-0017-05-000-00) and its supply based, located in Semanga Village, Sejangkung Sub-district, Sambas District, Kalimantan Barat Province, Indonesia against the requirement of Standard RSPO Principles and Criteria Indonesian National Interpretation 2013, endorsed September 2016 and Supply Chain Requirement for CPO Mill, November 2014.

Wilmar International Ltd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Wilmar International Ltd. has been registered since 16 August 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Agronusa Investama POM – PT Agronusa Investama which has 1 (one) mill and 1 (one) estate on **19 – 24 February 2017**

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001;2015) and Environmental Management System certification body (ISO 14001;2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

- f. Other issues related with assessment
