Smart Tbk. has applied to Mutuagung Lestari for RSPO annual surveillance to Leidong West POM – PT MP Leidong West Indonesia (RSPO Membership Number 1-0019-05-000-00) and its supply based, located in Palapa Sub District, Bangka Barat District, Bangka Belitung Province, Indonesia against the requirement of Standard RSPO Principles and Criteria Indonesian National Interpretation 2013, endorsed September 2016 and Supply Chain Requirement for CPO Mill, November 2014.

Smart Tbk. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Smart Tbk. has been registered since 30 January 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Leidong West POM – PT MP Leidong West Indonesia which has 1 (one) palm oil mill and 4 (four) oil palm estates on **06**th to **11**th **Maret 2017**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB).
