Notification on RSPO Surveillance-2 Assessment of Palm Oil Mill 4 – PT Dharma Satya Nusantara

Dear Stakeholders,

PT Dharma Satya Nusantara has applied to Mutuagung Lestari for RSPO annual surveillance to Palm Oil Mill 4 – PT Dharma Satya Nusantara (RSPO Membership Number 1-0135-12-000-00) and its supply based, located in Muara Wahau Village, Sub district of Muara Wahau, District of Kutai Timur, Kalimantan Timur Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

PT Dharma Satya Nusantara has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. PT Dharma Satya Nusantara has been registered since December 4, 2012 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Palm Oil Mill 4 – PT Dharma Satya Nusantara, has 1 (one) mill and 3 (three) estates on **14 - 18 April 2017**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2015) and Environmental Management System certification body (ISO 14001;2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

2. **Yudwi Wisnu Rahmanto** as auditor for Social/conflict & SCCS;

4. **Naila Karima** as auditor for Environment, Conservation & GHG Emission.

PT Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment,

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
