November 2014.

M.P. Evans Group PLC is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 4 (four) oil palm estate on **25**<sup>th</sup> **to 29**<sup>th</sup> **September, 2017.**
