### <u>Notification on RSPO Surveillance-1.2 Assessment of Jangkang POM – PT Sahabat Mewah dan Makmur</u> subsidiary of PT Austindo Nusantara Jaya Agri.

Dear Stakeholders,

PT Mutuagung Lestari will conduct Surveillance-1.2 Assessment at Jangkang POM - PT Sahabat Mewah dan Makmur (RSPO membership number 1-0032-07-000-00) – PT Sahabat Mewah dan Makmur and its supply base, located in Jangkang, Balok, Ladang Jaya, Sari Bunga and Air Ruak Villages, Jangkang Sub-District, Belitung Timur District, Kepulauan Bangka Belitung Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30<sup>th</sup> September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

PT Austindo Nusantara Jaya Agri has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Goodhope Asia Holdings Ltd. has been registered since 27<sup>th</sup> February 2014 as RSPO member. Mutuagung Lestari has arranged to conduct the assessment of Jangkang POM – PT Sahabat Mewah dan Makmur management unit which operating 1 (one) mill and 5 (five) estates on **30<sup>th</sup> October until 03<sup>rd</sup> November 2017.** 

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2015) and Environmental Management System certification body, Certification Body of Indonesian Sustainable Palm Oil (ISPO). Since June 2008, MUTU has been approved by RSPO Executive Board as a RSPO certification body and since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.
