## <u>Notification on RSPO Surveillance-1.1 Assessment of Nagasakti POM – PT Buana Wiralestari Mas</u> subsidiary of PT Ivo Mas Tunggal (RSPO Membership Number 1-0056-08-000-00)

Dear Stakeholders,

Ivo Mas Tunggal has applied to Mutuagung Lestari for RSPO annual surveillance to Nagasakti POM – PT Buana Wiralestari Mas (RSPO Membership Number 1-0056-08-000-00) and its supply based, located in Tapung Hilir Sub-District, Kampar District, Riau Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30<sup>th</sup> September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Ivo Mas Tunggal been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Ivo Mas Tunggal has been registered since June 17, 2008 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance assessment for Nagasakti POM – PT Buana Wiralestari Mas which has 1 (one) mill and 3 (three) estates on **30<sup>th</sup> October until 02<sup>nd</sup> November**, **2017**.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2015) and Environmental Management System certification body (ISO 14001;2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.
