# Notification on RSPO Surveillance-1.2 Assessment of Sekunyir POM – PT Indotruba Tengah (Sime Darby Plantation Sdn.Bhd)

Sime Darby Plantation Sdn Bhd has applied to Mutuagung Lestari will conduct Surveillance-1.2 Assessment at Sekunyir POM – PT Indotruba Tengah (RSPO Membership Number 1-0008-04-000-00) and its supply based, located in Village of Amin Jaya and Pembuang Hulu, Sub District of Pangkalan Banteng and Hanau, District of Kotawaringin Barat and Seruyan, Province of Kalimantan Tengah, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Sime Darby Plantation Sdn. Bhd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Sime Darby Plantation Sdn. Bhd has been registered since September 7, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Sekunyir POM – PT Indotruba Tengah which has 1 (one) mill and 2 (two) estates on 25 until 29 September 2017.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB).
