# Notification on RSPO Initial Assessment (Stage-2) of Kencana Sari Oil Mill – PT PP LONDON SUMATRA INDONESIA, Tbk (RSPO membership registration number 1-0015-04-000-00).

#### Dear Stakeholders.

PT PP London Sumatra Indonesia Tbk has applied to Mutuagung Lestari and will conduct Initial Certification Assessment at Kencana Sari Palm Oil Mill and its supply base, located in Kencana Sari Village, Kikim Sub-district, Lahat District, South Sumatera Province, Indonesia against the requirement of the RSPO Standard i.e. National Interpretation of Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO INA – NIWG, *endorsed by the RSPO Board of Governors* 30<sup>th</sup> September 2016) Republic of Indonesia and Supply Chain Requirement for CPO Mill (21 November 2014). The organization has achieved the first RSPO Certification in 30 April 2009.

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) mill and 2 (two) estates on 27 to 30 November 2017.
