**Notification on RSPO Annual Surveillance Assessment 1.1 of Teluk Siak POM – PT Aneka Inti Persada subsidiary of Sime Darby Plantation Sdn. Bhd (RSPO Membership: 1-0008-04-000-00, 7 September 2004)**

Dear Stakeholders,

PT Aneka Inti Persada subsidiary of Sime Darby Plantation Sdn. Bhd (RSPO Membership: 1-0008-04-000-00) – Teluk Siak POM has applied to Mutuagung Lestari and will conduct surveillance-1.1 at Teluk Siak POM and its supply base, located in Village of Meredan, Sub-district of Tualang, District of Siak, Riau Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30<sup>th</sup> September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Sime Darby Plantation Sdn. Bhd has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Sime Darby Plantation Sdn. Bhd registered since September 7<sup>th</sup>, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance assessment for Teluk Siak POM – PT Aneka Inti Persada which has 1 (one) mill and 3 (three) estates on **6 until 10 November 2017**.

Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2015) and Environmental Management System certification body (ISO 14001;2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body, Certification Body of Indonesian Sustainable Palm Oil (ISPO), Since March 2014, MUTU has been accredited by ASI (Accreditation Services International) as a RSPO certification body.

The assessor team for the certification assessment will consist of:

1. **Oktovianus Rusmin** as Lead Auditor for legal use aspect, social aspect, management conflict and supply chain.
2. **Mohamad Amarullah** as auditor for conservation aspect, waste management and environment aspect.
3. **Sahat Simarmata** as auditor Good Agricultural Practices and Good Manufacturing Practices.
4. **Benli Manurung** as auditor for occupational health and safety, transparency information and worker welfare

PT. Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment;

- a. Environmental protection within the estate or mill including use of pesticide and waste management.

- b. Biodiversity within the estate and mill
- c. Contribution for local development and opportunities for employment
- d. Provision of housing, sanitation, facility and education support
- e. Other issues related with the assessment
