(RSPO Membership: 1-0015-04-000-00) — Pahu Makmur POM has applied to Mutuagung Lestari and will conduct Intial Assessment at Pahu Makmur Palm Oil Mill and its supply base, located in Village of Tanjung Isuy, Sub district of Jempang and Bongan, District of Kutai Barat, Kalimantan Timur Province, , Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.
