Notification RSPO Surveillance-3 Assessment of Sungai Bengkal POM – PT Satya Kisma Usaha a subsidiary of SMART Tbk; 1-0019-05-000-00)

Dear Stakeholders,

SMART Tbk has applied to Mutuagung Lestari for RSPO annual surveillance to Sungai Bengkal POM – PT Satya Kisma Usaha (RSPO Membership Number 1-0019-05-000-00) and its supply based, located in Betung Bedarah Barat Village, Sub District of Tebo Ilir, District of Tebo, Jambi Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

SMART Tbk has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. SMART Tbk has been registered since January 30, 2005 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Sungai Bengkal POM – PT Satya Kisma Usaha which has 1 (one) mill and 3 (three) estates on **15 – 19 January 2018**.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001; 2015) and Environmental Management System certification body (ISO 14001; 2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support

f. Other issues related with assessment
