Dharma Satya Nusantara has applied to Mutuagung Lestari for RSPO annual surveillance to POM 3 – PT Dharma Satya Nusantara (RSPO Membership Number 1-0135-12-000-00) and its supply based, located in Village of Muara Wahau, Sub District of Muara Wahau, District of Kutai Timur, Province of East Kalimantan, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30<sup>th</sup> September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Dharma Satya Nusantara has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Dharma Satya Nusantara has been registered since 4 December 2012 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of POM 3 – PT Dharma Satya Nusantara which has 1 (one) mill and 3 (three) estates on **15 – 20 January 2018**.
