Golden Agri Resources Ltd has applied to Mutuagung Lestari for RSPO annual surveillance to Tanjung Kembiri POM – PT Forestalestari Dwikarya (RSPO membership number 1-0096-11-000-00) and its supply based, located in Kembiri Village, Membalong Sub District, Belitung District, Bangka Belitung Province, Indonesia against the requirement of the RSPO Principles and Criteria Indonesian National Interpretation 2013, endorsed September 2016 and Supply Chain Requirement for CPO Mill, November 2014.

Mutuagung Lestari has arranged to conduct the annual surveillance of Tanjung Kembiri POM – PT Forestalestari Dwikaryawhich has 1 (one) mill and 2 (two) estate on **12 – 15 February 2018**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990.
