Notification on RSPO Recertification Assessment of Golden Agri-Resources Ltd (PT Sumber Indah Perkasa and PT Binasawit Abadi Pratama – Sungai Rungau POM).

Dear Stakeholders,

Golden Agri Resources Ltd has applied to Mutuagung Lestari for RSPO annual Re-Sertification to Sungai Rungau POM – PT Sumber Indah Perkasa and PT Binasawit Abadipratama (RSPO Membership Number 1-0096-11-000-00) and its supply based, located in Rungau Raya Village, Sub District of Danau Seluluk, District of Seruyan, Province of Central Kalimantan, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Golden Agri Resources Ltd has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Golden Agri Resources Ltd has been registered since March 31, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Sungai Rungau POM – PT Sumber Indah Perkasa which has 1 (one) mill and PT Binasawit Abadipratama which has 5 (five) estates on **16 – 20 April 2018**.
