Notification on RSPO Surveillance-4 Assessment of Nilo POM 2 – PT Adei Plantation & Industry a subsidiary of Kuala Lumpur Kepong Bhd.

Dear Stakeholders,

Kuala Lumpur Kepong Bhd. has applied to Mutuagung Lestari for RSPO annual surveillance to Nilo POM 2 – PT Adei Plantation & Industry and its supply based, located in Pelalawan Sub District, Pelalawan District, Riau Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Kuala Lumpur Kepong Bhd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Kuala Lumpur Kepong Bhd. has been registered since October 8, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Nilo POM 2 – PT Adei Plantation & Industry which has 1 (one) palm oil mill and 2 (two) oil palm estates on 12th - 16th March 2018.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001:2015) and Environmental Management System certification body (ISO 14001:2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body. Since March 2014, MUTU has been accredited by Accreditation Services International as a RSPO certification body.

The assessor team for the certification assessment will be led of: **M Rinaldi** (*Lead Auditor*) and other team assessor from PT Mutuagung Lestari

PT Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment:

- b. Biodiversity within the estate and mill
- c. Opportunities for employment
