Sime Darby Plantation Sdn. Bhd. has applied to Mutuagung Lestari for RSPO annual surveillance to Pondok Labu POM – PT Paripurna Swakarsa (RSPO Membership Number 1-0008-04-000-00) and its supply based, located in Pondok Labu Village, Pamukan Selatan Sub-District, Kotabaru District, Kalimantan Selatan Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Sime Darby Plantation Sdn. Bhd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Sime Darby Plantation Sdn. Bhd. has been registered since September 7, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Pondok Labu POM – PT Paripurna Swakarsa which has 1 (one) mill and 4 (four) estates on 14 - 18 May 2018.

Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. The assessor team for the certification assessment will be led of: **Sofyan Hadi Lubis** (*Lead Auditor*) and other team assessor from PT Mutuagung Lestari.
