Dear Stakeholders,

Golden Agri Resources Ltd. has applied to Mutuagung Lestari for RSPO Recertification to Llbo POM – PT Ivo Mas Tunggal (RSPO Membership Number 1-0096-11-000-00) and its supply based, located in Village of Samsam, Sub District of Kandis, District of Siak, Province of Riau, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014.

Golden Agri Resources Ltd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. Golden Agri Resources Ltd. has been registered since March 31, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the Recertification of Libo POM – PT Ivo Mas Tunggal which has 1 (one) mill and 3 (three) estates and 1 (one) smallholder on **25**th – **28**th June 2018.
