PT PP London Sumatra Indonesia Tbk has applied to Mutuagung Lestari and will conduct annual surveillance at Belani Elok Palm Oil Mill and its supply base (RSPO Membership Number 1-0015-04-000-00, *Member ID*: RSPO_PO1000002218) located in Beringin Makmur Village, Rawas Ilir Sub-district, Musi Rawas District, Sumatera Selatan Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

PT PP London Sumatra Indonesia Tbk has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. PT PP London Sumatra Indonesia Tbk has been registered since November 05, 2004 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Belani Elok which has 1 (one) mill and 5 (five) estates on 06 – 10 August 2018.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB).
