PT Perkebunan Nusantara IV has applied to Mutuagung Lestari and will conduct Annual Surveillance Assessment at Pabatu Palm Oil Mill (RSPO Membership: 1-0082-09-000-00 and Member ID: RSPO\_PO1000002539). and its supply base, located in Dolok Ilir 1 Village, Dolok Batu Nanggar Sub-District, Simalungun District, Sumatera Utara Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30<sup>th</sup> September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

PT Perkebunan Nusantara IV has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. PT Perkebunan Nusantara IV has been registered since 29 June, 2009 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance assessment of PT Perkebunan Nusantara IV – Dolok Ilir POM which has 1 (One) palm oil mill and 1 (one) oil palm estate on 27th – 31st August 2018.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB).
