PT Mutuagung Lestari will conduct Surveillance-3 Assessment at PT Gunajaya Karya Gemilang – Kendawangan POM (RSPO membership number 1-0043-07-000-00) – PT Gunajaya Karya Gemilang and its supply base, located in Kendawangan Sub District, Ketapang District, Kalimantan Barat Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

Bumitama Agri Ltd. has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Bumitama Agri Ltd. has been registered since October 08, 2007 as RSPO member. Mutuagung Lestari has arranged to conduct the assessment of Kendawangan POM – PT Gunajaya Karya Gemilang management unit which operating 1 (one) mill and 6 (six) estates on 24th until 29th September 2018.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990.
