Golden Agri Resources Ltd has applied to Mutuagung Lestari for RSPO annual surveillance to Ramarama POM – PT Ramajaya Pramukti (RSPO Membership Number 1-0096-11-000-00) and its supply based, located in District of Kampar, Riau Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

Golden Agri Resources Ltd been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Golden Agri Resources Ltd has been registered since March 31, 2011 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance assessment for Ramarama POM – PT Ramajaya Pramukti which has 1 (one) mill, 1 (one) estate, and 1 (one) smallholder on 16<sup>th</sup> until 19<sup>th</sup> October, 2018.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China.
