Salim Ivomas Pratama Group has applied to Mutuagung Lestari for RSPO annual surveillance to Turangie POM – PT PP London Sumatra Indonesia Tbk (RSPO Membership Number 1-0041-07-000-00) and its supply based, located in Salapian and Bahorok Sub-District, Langkat District, Kalimantan Selatan Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014, revised on 14 June 2017.

Salim Ivomas Pratama Group has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO certified Sustainable Palm Oil. Salim Ivomas Pratama Group has been registered since September 23, 2007 as RSPO member. PT Mutuagung Lestari has arranged to conduct the annual surveillance of Turangie POM – PT PP London Sumatra Indonesia Tbk which has 1 (one) mill and 3 (three) estates on 03<sup>rd</sup> until 07<sup>th</sup> December 2018.

PT. Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990.
