Notification of RSPO Initial Certification of Sungai Cempaga POM – PT Windu Nabatindo Abadi and PT Nabatindo Karya Utama a subsidiary Bumitama Agri Ltd

Dear Stakeholders,

PT Windu Nabatindo Abadi and PT Nabatindo Karya Utama a subsidiary Bumitama Agri Ltd (RSPO Membership: 1-0043-07-000-00) has applied to Mutuagung Lestari and will conduct initial certification at Sungai Cempaga POM and its supply bases, located of Tumbang Koling Village, Cempaga Hulu Sub-District, Kotawaringin Timur District, Kalimantan Tengah Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

Sungai Cempaga POM – PT Windu Nabatindo Abadi and PT Nabatindo Karya Utama has successfully been registered in the PalmTrace system with PalmTrace member ID is RSPO_PO1000004930. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to Sungai Cempaga POM – PT Windu Nabatindo Abadi and PT Nabatindo Karya Utama the organization which operating 1 (one) palm oil mill and 5 (five) estates on **11 to 15 February 2019**.
