PT Dharma Satya Nusantara has applied to Mutuagung Lestari for RSPO annual surveillance to Palm Oil Mill 4 – PT Dharma Satya Nusantara (RSPO Membership Number 1-0135-12-000-00) and its supply based, located in Muara Wahau Village, Sub district of Muara Wahau, District of Kutai Timur, Kalimantan Timur Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30 September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 june 2017.

PT Dharma Satya Nusantara has been taking an active role in the RSPO certification processes and implementing programme to achieve RSPO Certified Sustainable Palm Oil. PT Dharma Satya Nusantara has been registered since December 4, 2012 as RSPO member. Mutuagung Lestari has arranged to conduct the annual surveillance of Palm Oil Mill 4 – PT Dharma Satya Nusantara, has 1 (one) mill and 3 (three) estates on 18 to 22 March 2019.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB).
