Sime Darby Plantation Berhad has applied to Mutuagung Lestari will conduct annual surveillance assessment at Angsana POM – PT Ladangrumpun Suburabadi (RSPO Membership Number 1-0008-04-000-00) and its supply based, located in Sebamban Village, Sub District of Sei Loban, District of Tanah Bumbu, Province of Kalimantan Selatan, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014, revised on 14 June 2017.

Sime Darby Plantation Berhad has been taking an active role in the RSPO certification processes and implementing programme to maintain RSPO certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct the annual surveillance of Angsana POM – PT Ladangrumpun Suburabadi which has 1 (one) mill and 5 (five) estates on 17 to 21 June 2019.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990.
