Sime Darby Plantation Berhad has applied to Mutuagung Lestari for RSPO annual surveillance to PT Bina Sains Cemerlang - Sungai Pinang POM and its supply based, located in Sungai Pinang Village, Muara Lakitan Sub-district, Musi Rawas District, Sumatera Selatan Province, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

PT Bina Sains Cemerlang has been taking an active role in the RSPO certification processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct the annual surveillance of Sukamandang POM – PT Bina Sains Cemerlang which has 1 (one) palm oil mill and 2 (two) estates on **22 to 26 July 2019** 

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990.
