FGV HOLDINGS BERHAD has applied to Mutuagung Lestari for RSPO annual surveillance of FGVPISB Kilang Sawit Serting Hilir and its supply based, located 72100 Bandar Baru Serting, Negeri Sembilan, Malaysia against the requirement of the Malaysia National Interpretation (MYNI) 2019 of the RSPO Principles and Criteria 2018 for Sustainable Palm Oil Production, endorsed by the RSPO Board of Governors on 7th November 2019 and Supply Chain Requirement for CPO Mill, November 2014, revised on 14 June 2017.

FGV HOLDINGS BERHAD has been taking an active role in the RSPO certification processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct the annual surveillance of Kilang Sawit Serting Hilir which has 1 (one) mill and 8 (eight) oil palm estates on **02 to 07 February 2020**.
